The online form will require, among other details the following ones:

- Short speaker's bio (max 400 characters).
- Submission title (max 100 characters).
- Brief description of the proposal (max 500 characters). Detailed summary of the presentation (maximum 2500 characters) It should include: scientific- technological, strategic and industrial objective, background and technological and business context, improvement over what exists, methodology, results, conclusions, level of implementation, future forecasts and upcoming challenges.
- Keywords (max 200 characters).

The deadlines to take into consideration are:

- Proposal entry deadline: 30th January 2021.
- Selected proposal confirmation deadline: confirmation will start on 15th February 2021. Between those deadlines, the Steering Committee reserves the right to ask for any clarification or additional information about the submitted entries.
